Pele u roala lieta ho leba ofising ea Master of the High Court ho ea kopa Letter of Executorship, u tlameha ho lokisa litokomane tse 'maloa. Haeba u tšoare litokomane tsena letsohong sena se tla potlakisa tšebetso .

1. Tlatsa Death Notice (Form J294*):

- Ena ke foromo ea molao ea ho tsebisa Master of the High Court mabapi le lefu.
- Foromo ena e hloka lintlha tse kang lebitso le feletseng la mofu, nomoro ya ID, boemo ba lenyalo, le aterese ya bolulo.

2. Litokomane tsa ID:

- Litokomane tsa khopi ea ID e netefalitsoeng bakeng sa bobeli moamoheli oa liabo ea hlokaheleleng le ea mokopi

3. Lengolo la netefatso ea lefu ea Mantlha kapa e Netefalitsoeng:

- Fumana tsena ho tsoa ho Department of Home Affairs.

4. Thato le lengolo la lefa la ho qetela (haeba li fumaneha):

- Haeba mofu a tlohetse lengolo la thato ea mofu (will) le sebetsang, u tlameha ho fana ka lengolo la mantlha la thato ea mofu kapa khopi e netefalitsoeng.
- Haeba ho se na lengolo la thato ea mofu, estate (thepa) e tla sebetsoa ka intestate, sena se bolela hore kabo ea thepa e tla latela melao e tekiloeng ho Intestate Succession Act.

5. Setifikeiti sa lefu:

- Sa bana ba mofu, bara le barali babo mofu, kapa batsoali ba moamoheli oa liabo ea hlokaheleleng.
- Sena ke ho bona hore ha ho batho ba bang ba phelang ba ka hlahlelang litleleimi bakeng sa thepa ea mofu.

6. Tokomane ea antenuptial contract:

- Haeba e le lenyalo leo ho sa kopaneloang thepa

7. Lengolo la molao la tlhale / deed of settlement:

- Haeba ho sebetsoa

8. Lenane la thepa ea mofu (Foromo J243*):

- Foromo ena e neha Master leseli la kapele la thepa le thepa e kolotuoang ke estate.
- Thathamisa thepa kaofela e sa jarehang le e jarehang, e kang real estate, likoloi, le matsete afe kapa afe.

9. Afidaviti ya Beng ka Mofu (Next of Kin Affidavit) (haeba ho hlokaheleleng):

- Ka linako tse ling e a hlokaheleleng ho netefatsa lelapa la mofu, ka ho qollehileng haeba ho se na lengolo la thato ea mofu le sebetsang.

10. Ho thongoa joalo ka Executor (haeba lebitso le sa ngoloa lengolong la thato ea mofu):

- Haeba lengolo la thato ea mofu le thontse uena joaloka executor, kenyeletsa khopi ea polelo e bolelang joalo kapa lengolo kaofela la thato ea mofu le bontšang ho thongoa.

11. Kamohelo ea Botšephehi ea Mohlokomeli oa Lefa (Foromo J190):

- Mohlokomeli oa lefa e sisintsoeng e tlameha ho tlatsa le ho tekena foromo ena ho amohela boikarabelo ba hae.

12. Tiisetso bakeng sa tsamaiso ea lefa (Bond of Security):

- Haeba lengolo la mofu le sa behelle thoko executor kapa haeba Master a nahana hore ho a hlokaheleleng, u tlameha ho fumana bond of security ho tsoa khamphaning ea inshorene.
- The Master of the High Court e tla u thusa ntle le 'muelli oa molao haeba thepa kapa estate e sa fete R250 000.
- Haeba thepa e feta R250 000 u tlameha ho iphumanela 'muelli oa molao eo u khethang hore a u thusa ka botsamaisi ba thepa ea mofu.
- U ka ikopanya le ofisi e haufi le uena ea TEBA bakeng sa keletso mabapi le ho fumana 'muelli oa molao ka sepheo sena.
